### 15. Comments:

This location assessment is for the construction of the PA 22-21 well pad. There will be 15 new wells drilled when complete. Surface and minerals are owned by the Federal Government. The location reference point for this pad is the PA 311-21 well from which all measurements were taken. Since this well pad is within a sensitive area, Williams will employ the following BMP's to support protection of surface and ground water: 1) Williams will ensure 110% secondary containment for any volume of fluids contained at well site during drilling and completion operations. 2) Williams will implement best management practices to contain any unintentional release of fluids. 3) A closed loop system will be used. Reference Photos will be provided at a later date after snow melt.

**All representations, stipulations and conditions of approval stated in this Form 2A for this location shall constitute representations, stipulations and conditions of approval for any and all subsequent operations on the location unless this Form 2A is modified by Sundry Notice, Form 4 or an Amended Form 2A.**

The moisture content of any drill cuttings in a cuttings pit, trench, or pile shall be as low as practicable to prevent accumulation of liquids greater than de minimis amounts. At the time of closure, the drill cuttings must also meet the applicable standards of table 910-1.

No portion of any pit that will be used to hold liquids shall be constructed on fill material, unless the pit and fill slope are designed and certified by a professional engineer, subject to review and approval by the director prior to construction of the pit. The construction and lining of the pit shall be supervised by a professional engineer or their agent. The entire base of the pit must be in cut.
