This amended location assessment is for the addition of 4 wells to the PA 34-4 pad. There are currently 4 existing wells with another 9 permitted for drilling. There will be a total of 17 when all are drilled. This pad is fully constructed with exception of conductors for the additional 4 wells. There will be no additional disturbance or dirt work. We have an existing approved form 2A for the permitted wells. Surface is owned in fee. The location reference point for the pad is the PA 534-4 well. All measurements were taken from this point. The location is located within a 317B Surface Water Supply area buffer (500' - 2640' ft. zone). All public water supply systems have been notified.
