Dear Mr. Erion:

In compliance with Colorado Oil and Gas Conservation Commission (COGCC) Rule 303.d.(3).N and Rule 317B, Bill Barrett Corporation (BBC) would like to notify you that the subject oil and gas location, this pad is proposed to be located within the external and intermediate buffer zones of Rule 317B. Attached are a hydrology map and a Rule 317B map for your review. Per Rule 317B.d.(5) and Rule 317B.e.(3), operators are required to send notification of affected impacted to Public Water Systems within fifteen (15) stream miles downstream of the Drilling, Completion, Production and Storage ("DCPS") Operations prior to commencement of new surface disturbing activities at the site. Please note that Rule 317b.d requirements will be met appropriately for the DCPS operation.

Please be advised that, as required by COGCC Rule 317B, BBC has an emergency response plan in place to protect the City of Rifle's Public Water System.




