Mari,

I have been reviewing the Donovan D 02-03 Tank **Form 2A** (#400062179). COGCC requests the following clarifications regarding the data Noble has submitted on or attached to the Form 2A prior to passing the Oil and Gas Location Assessment (OGLA).

1. **Water Resources (Section 14):** Form 2A also indicates the depth to groundwater to be 24 feet bgs for a well located 648 feet away from the proposed tank pad. COGCC guidelines require designating all locations with shallow groundwater a **sensitive area** and requiring the following condition of approval (COA):

COA 5 - Operator must implement best management practices to contain any unintentional release of fluids.

COGCC would appreciate your concurrence with attaching this COA to the Form 2A permit prior to passing the OGLA review. If you have any questions, please do not hesitate to call me at (970) 309-2514 (cell), or email. Thanks.
