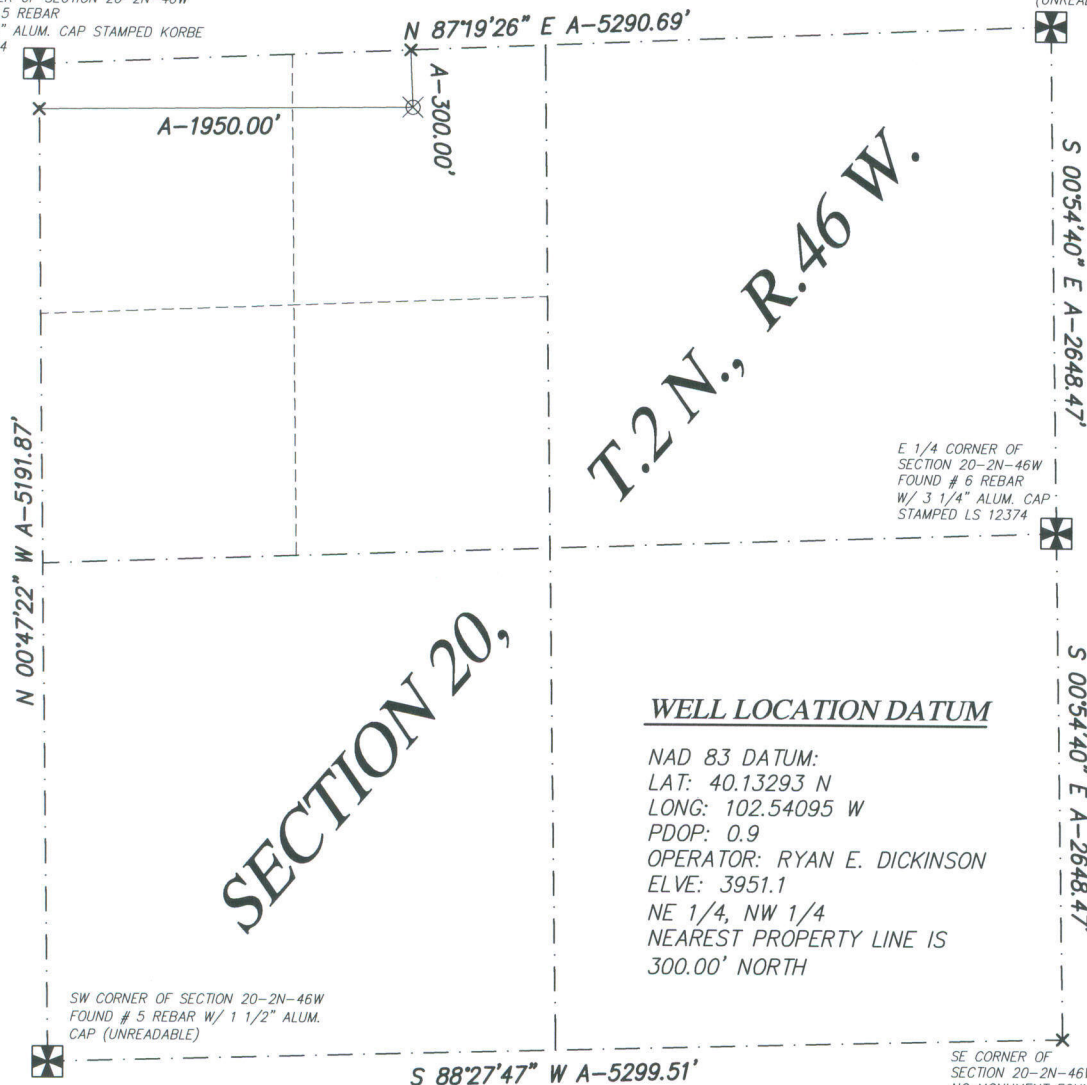


**THE ACCOMPANYING DRAWING IS AN ACCURATE REPRESENTATION
