Well pad has three wells: existing Camenisch #32-16, API#05-123-23578, staked but not drilled Camenisch #16-32-37R, API #05-123-26083 and Camenisch #16-32-39R, API#05-123-26082. Hydrology map and well location map indicate an irrigation pipe (seasonal) ditch with catchment basin located within 50 feet of the well pad. Drilling on this pad will take place during the winter months, due to the irrigated field and growing season timeframes. BMP will occur during drilling and the irrigation pipe ditch/catchment area will not be impacted.
