Nearest railroad is over 1 mile from location. Nearest water well permit no. 13958-R. This 2-well, multi-well pad includes: proposed Marley C01-17 and Marley C01-22D. Both wells will be serviced by a new production facility to be located 1225' east, southeast of the locations. The existing facility for Rein 1 & 1-8 wells will also be moved south to this new facility location. Facility equipment will be: 3 tanks, 3 separators, 4 three-phase flowlines, 3 EFM, 3 gas PL's, 3 water vaults, 1 VOC.
