In response to your email of Thursday July 1, 2010 East Resources has reviewed the conditions of approval for the WFU Durham 1-31 and 2-31. East Resources response to your requests is as follows:

1. **Facilities (section 5):** The subject pit is only intended to be used as a blooie pit for the drilling operation. This pit is not classified as a flare pit and should not require a special pit permit given the classifications as it states in COGCC rules and regulations. Please reference the Production/Reclaim Layout drawing. The crossed and dashed area on the drawing will be reclaimed after the well has been completed. Please note that the Blooie pit in this drawing is part of the 1.08 acres that are to be reclaimed.
2. **Water Resources (Section 14):** Upon your research regarding water resources and depth to ground water, would you please make the changed of ground water from 0 feet to 88 feet on the form 2A.
3. **Rule 303.d.(3).F.ii.aa and bb:** I have attached the four pictures that were submitted in the permit package (please see attached). They are labeled and have the reference area as the location looking at the stake from all four cardinal directions where the well is to be drilled.
