The Coleman C22-17 will be commingled with the Coleman C22-814 and the Coleman 22-114. The nearest WW, permit 12500-R is a plugged well. WW permit 12500-R-R was used for static level and is approx 2,160 feet away. Distances listed at 5280 are over 1 mile from location.
