Nearest railroad is greater than 1 mile from proposed tank battery location. Nearest water well depth to ground water was taken from Receipt #9059265 Permit #4574-F. HERBST C22-24 will need 1 separator, 1 water vault, 1 tank, 1 three phase flowline, 1 gas pipeline and 1EFM. COLEMAN C22-21D will need 1 separator, 1 water vault, 1 tank, 1 three phase flowline, 1 gas pipeline and 1EFM. The existing facility for the Cantrell 1 and Cantrell 22-12 consists of will need 1 separator, 1 water vault, 1 tank, 2 three phase flowline, 1 gas pipeline and 1EFM. The facility for the Herbst C22-24 and Coleman C22-21D will be located at the same battery as the existing Cantrell 1 and Cantrell C22-12 battery. The battery for the HERBST C22-24, COLEMAN C22-21D, CANTRELL1 AND CANTRELL 22-12 will consist of 3 separators, 3 water vaults, 3 tanks, 4 three-phase flowlines, 3 gas pipelines and 3 EFM's.
