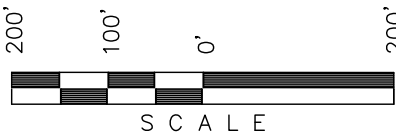

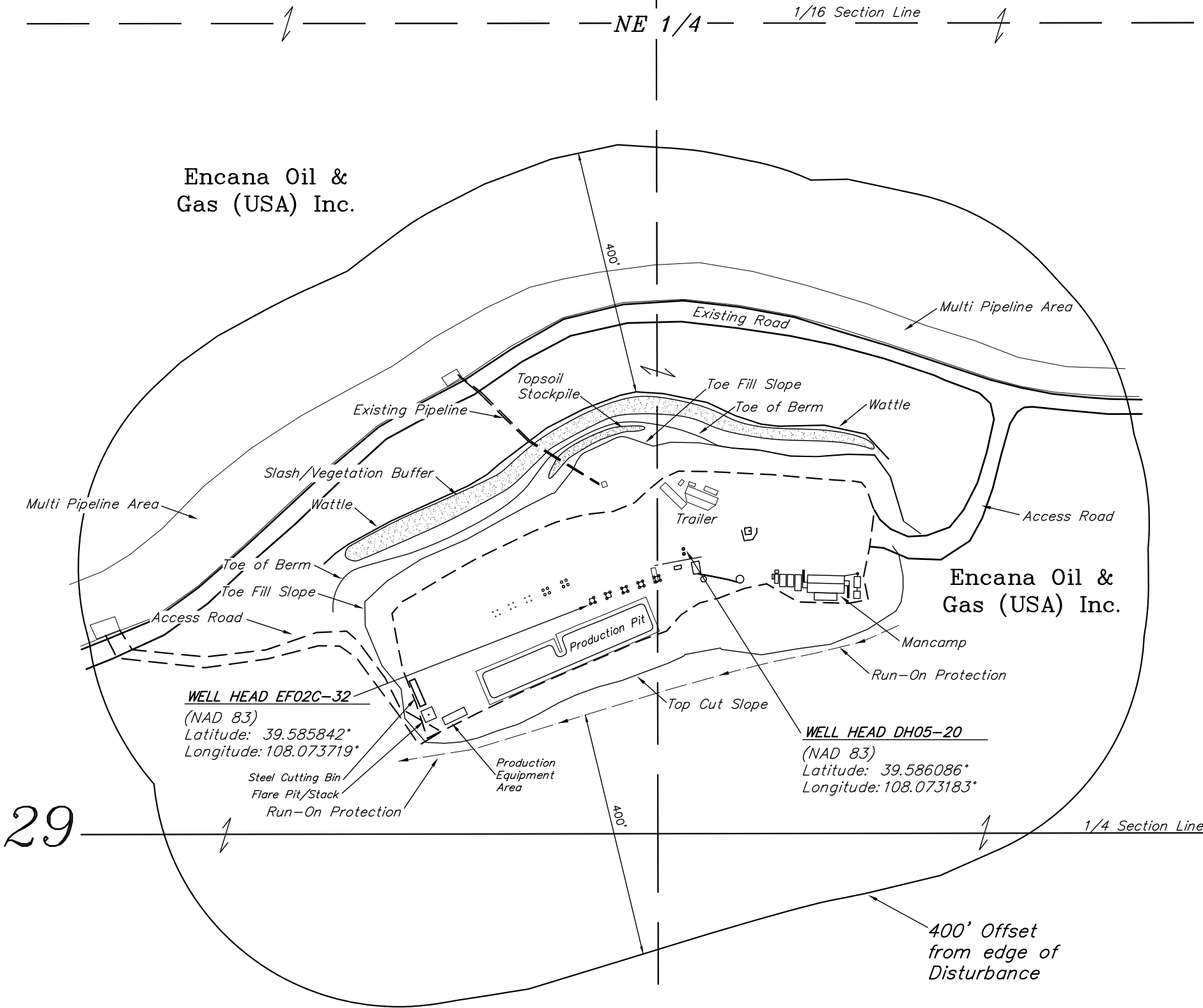
LOCATION DRAWING FOR
