Water well permit number 15882-A, which is the closest water well with static water level information to our proposed Holstein 11-28H. was used to determine the depth to ground water. The referenced water well is approximately 1500 ft to the SW of the Holstein 11-28H. It has a listed static water level of 60' and is at an elevation of 5260 ft. The ground elevation of the proposed Holstein 11-28H is 5236 ft, which is 24 ft lower. Therefore, the estimated depth to ground water is approximately 36 ft.
