Notice of Drilling Operations

Dear Mr. MacDonald:

In accordance with the requirement of Rule 305.e.(1).B. of the Colorado Oil and Gas Conservation Commission (COGCC), this letter serves as a 30-day notice by Petroleum Development Corporation (PDC) of its intention to conduct drilling operations on the captioned wells.

I will be contacting you shortly to schedule a consultation to discuss the location of the wellsite(s), access roads, production facilities and other related matters; however the well location may be staked prior to a consultation. Pursuant to Rule 306, you may also use the enclosed postage prepaid postcard to request a consultation or to designate a representative for surface consultation.

For documentation purposes, the great horned owl nest located in a single cottonwood tree approximately 600 feet northwest of the proposed 25D location, has been abandoned, according to Danny Kipp with Coors Energy. I also did a field search on 11/25/09 looking for the nest and/or owls and did not see any evidence of any owls or the nest. I spoke with Eric Lowry, Colorado Division of Wildlife on 12/2/09, advised him of this status, told him that PDC would like to initiate its well permitting process ASAP, and asked if CDOW had any problems with our permitting since the owl nest was gone. He said if there was no sign of the nest or the owl flying around in the area, it would be acceptable for PDC to get started on our permitting.

Also enclosed is a site diagram that depicts the area, per COGCC rules, within which the well(s) may be located, and the proposed location of the well(s), access road(s), and production facilities. Additionally, enclosed please find a copy of the COGCC's brochure describing surface owner rights and responsibilities, and a copy of the COGCC's on-site inspection policy.

As surface owner you have the responsibility for notifying any affected tenant farmer, lessee or other party that may own or have an interest in any crops or surface improvements that could be affected by these proposed operations.


