WATER PERMIT #41766-MH; There is a concrete walled irrigation ditch 210 feet from the site and dirt ditches 26, 307 and 554 feet away from the site. Based on site specific conditions evaluated within the context of topography, geography, nature of operations and proximity to surface water, APC will implement BMPs in accordance with good engineering practices to mitigate the potential for impacts to surface water from an unintentional discharge of fluid. Kerr McGee Oil & Gas Onshore LP requests approval of a Rule 318Aa and Rule 318Ac exception location: Wellhead is to be located outside of a GWA drilling window and will be located more than 50' from an existing well location. Surface Owner consent is given by article 3.d of the Surface Use Agreement.
