



5. **DESCRIBE PROPOSED OR COMPLETED OPERATIONS**

We have increased plans for our surface casing setting depth from 1500' to approx. 2500'.

We will drill a 14 3/4" hole to approx. 2500' and set approx. 2500' of 8 5/8", J-55, 32# surface casing.

We will cement the surface casing with 775 sk Halliburton Versacem System lead cement mixed at 12.3#/gal followed by 325 sk of Halliburton Swiftcem system tail cement mixed at 14.2 #/gal.

We will run a 1.9" parasite string landed at approx. 2400' along side the surface casing.
