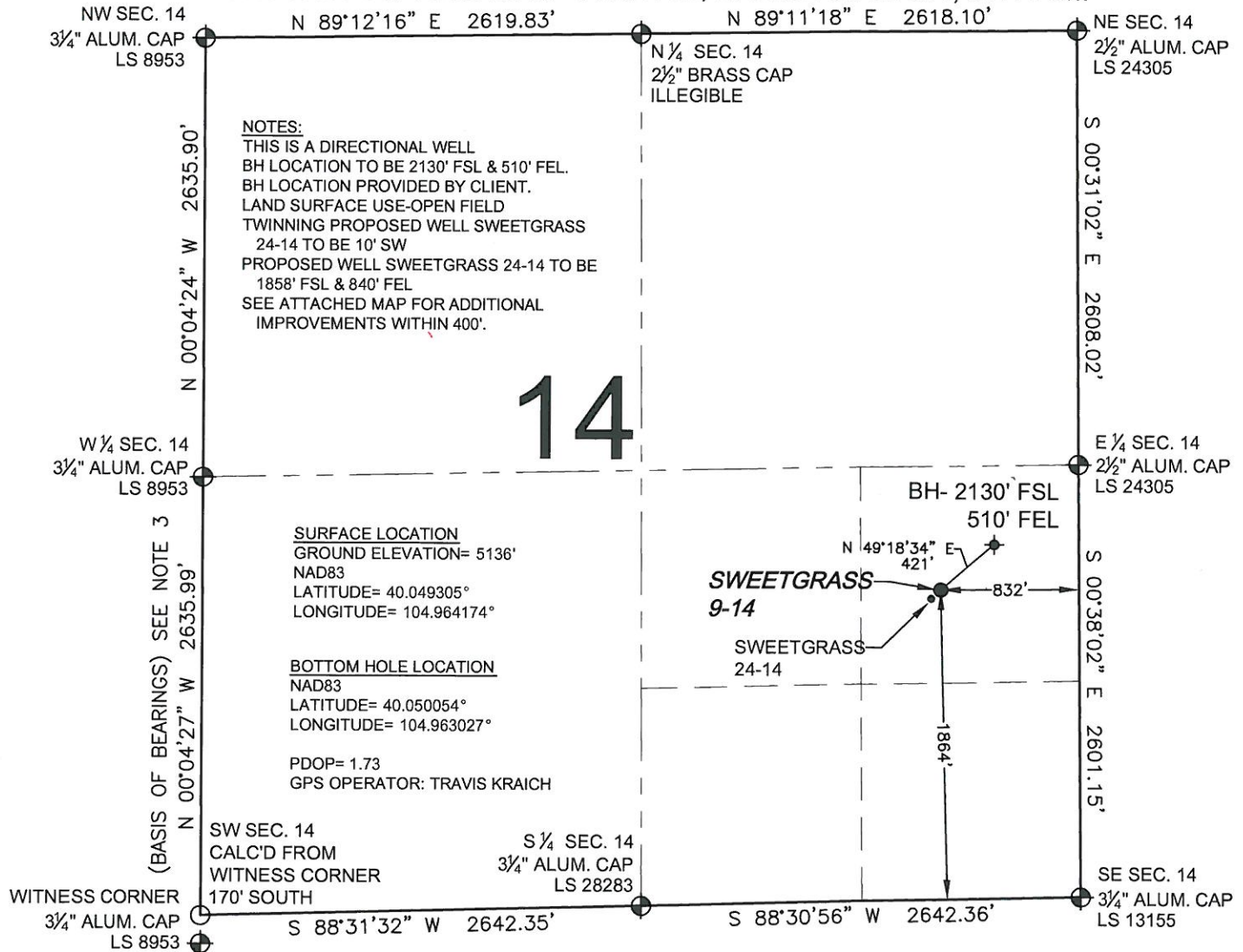


# WELL LOCATION CERTIFICATE: SWEETGRASS 9-14

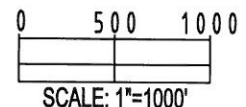

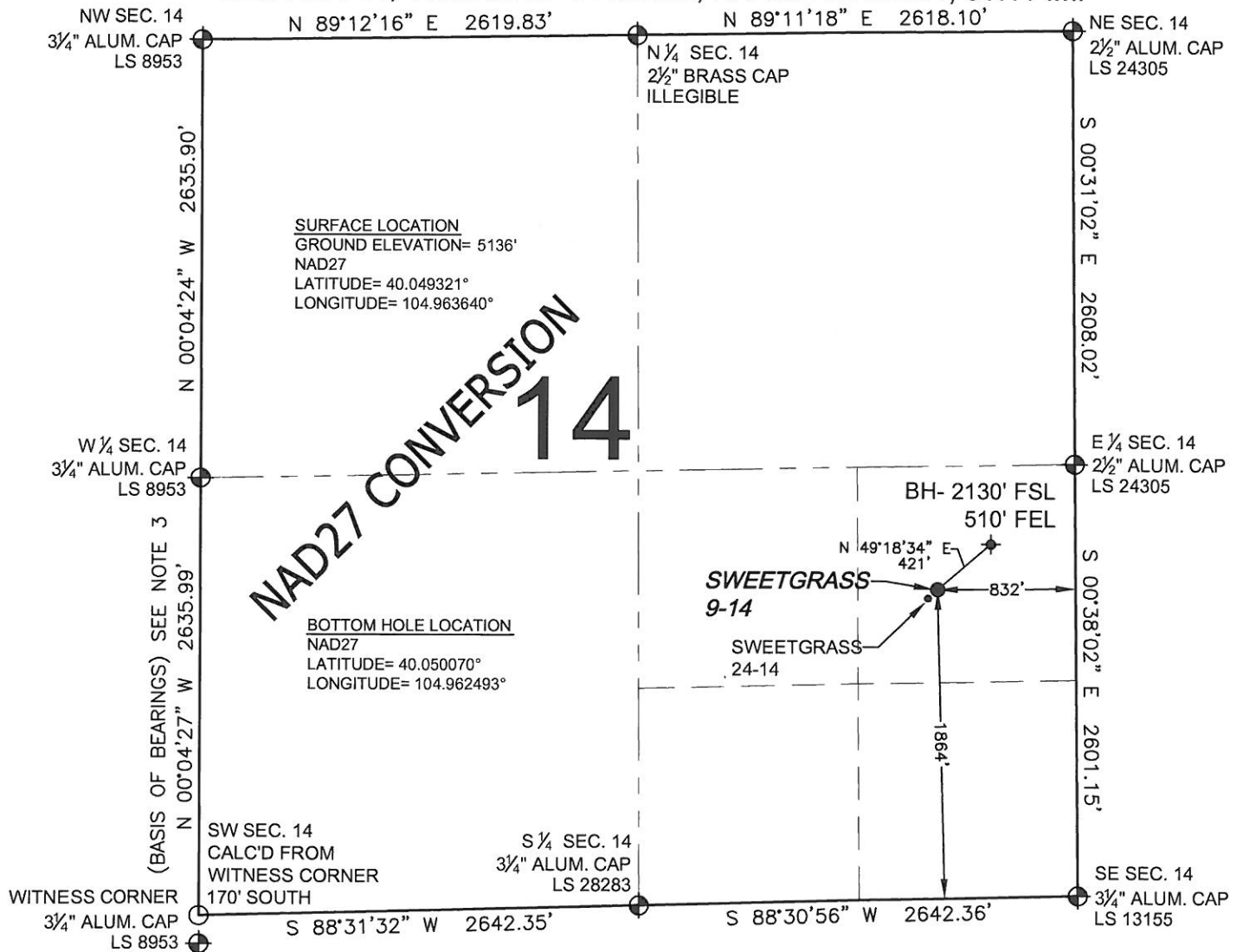

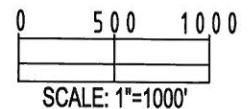
