Dear Mr. Neslin:

Entek GRB LLC (Entek) hereby requests that the Director grant a waiver to Colorado Oil and Gas Conservation Commission (COGCC) Rule 318 a., for the above referenced well. The surface location, pertaining to the Application for Permit to Drill (APD), does not conform to COGCC Rule 318 a. due to topographical constraints. The preferred location was agreed upon by Entek and the Bureau of Land Management (BLM) at an onsite meeting held August 4, 2010. Attached please find an approved Sundry Notice (SN) from BLM for the Exception Location Request.

The wellsite was originally staked at 2,257' FSL 431' FEL (NE/4 SE/4) of Sec. 24 T12N R89W on May 6, 2010, by Choice Engineering Services (Choice), surveyor, on a site that was geologically and topographically acceptable. The Bottom Hole Location (BHL) is located at $\pm 1,027'$ FSL $\pm 725'$ FEL (SE/4 SE/4) of Sec. 24 T12N R89W with in a 50' radius.

Entek requests the Director approve the proposed exception location. The federal SN requesting an exception location was approved on September 16, 2010, indicating that the surface owner acknowledges the placement of the well and the surface location.

Entek GRB LLC (Entek) hereby requests the Bureau of Land Management's (BLMs) approval of the Sundry Notice (SN) for a surface exception waiver for the above referenced well. This SN has been submitted via the Well Information System (WIS). The well does not conform to the Colorado Oil and Gas Conservation Commission (COGCC) Rule 318 a., pertaining to the Application for Permit to Drill (APD), for statewide spacing requirements due to topographical constraints. The preferred location was agreed upon by Entek and the BLM at an onsite meeting held August 4, 2010.

COGCC Rule 318 a. states that a well drilled to a depth of 2,500' or more must be located 600' from any lease line. The above referenced well is located 431' from the East line of the section due to topographical constrains and which is in violation of Rule 318 a.
