Notification to Public Water Supply System, Per Rule 317B

Mr. Pace:

In compliance with Colorado Oil and Gas Conservation Commission Rule 317B, Antero Resources Piceance Corporation would like to notify you that the subject oil and gas location, McLin C Pad, is proposed to be located in a COGCC Rule 317B external buffer zone (501'-2640' from surface water supply area), as shown in the attached Hydrology Map. Specifically, the proposed oil and gas location will be approximately 1400' from Divide Creek and the Town of Silt's public water supply system is within fifteen (15) stream miles of our proposed location. Per COGCC Rule 317B.d., operators are required to send notification to "potentially impacted Public Water System(s) within fifteen (15) stream miles downstream of the DCPS Operation prior to commencement of new surface disturbing activities at this site."

Please be advised that, as required by COGCC Rule 317B, Antero has an emergency response plan in place and if a spill or release that threatens to impact the Town of Silt's Public Water System is discovered, we will notify you immediately following discovery of the release.






1000' Radius From Pad Disturbance
