The well pad has been constructed, there are no producing wells on this location; there is currently no drilling rig on this pad. Drilling operations are projected to commence sometime in 2010. A semi-closed loop system will be used. Per GarCo Vacation Ordinance dated 10-5-1987, CR 213 is now OXY's private property north of Sec 8, 7S, 97W, 6 PM. Oxy will comply with new "Notice to Operators" regarding reserve pits (June 12, 2008). Oxy will provide appropriate housing for essential personnel in order to conduct safe, efficient drilling operations at this well site.
