Dear Mr. Kelly:

The Colorado Oil and Gas Conservation Commission (COGCC) has specific guidelines and procedures regarding surface activities. These rules stipulate an operator must give an affected surface owner notice in writing at least thirty (30) days prior to drilling an oil and gas well (COGCC Rule 305).

It is Slawson's intention to begin operations to drill an oil and gas well on the lands described above before November 15, 2010. Operator may drill the well thirty (30) days from this date or sooner if your approval to waive the thirty day notices requirement is given below. It is your responsibility to notify the tenant farmer, if applicable, of this proposed operation.

Slawson Exploration Company, Inc. has met with Mr. Matt Pollart of the Colorado State Board of Land Commissioners office in Greeley, Colorado to discuss the proposed location of well sites, access roads, production facility and reclamation.


