



Gentlemen

EnCana Oil & Gas (USA) Inc ("EnCana") has staked four (4) wells from the existing Wandell #1 well site located in the NE/4NE/4 of Section 7, Township 2 North, Range 67 West (see attached survey plats) These wells are being drilled under the rules and regulations of the Colorado Oil and Gas Conservation Commission's ("COGCC") Rule 318A known as the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule

This rule states that all boundary infill wells be drilled from the same surface locations as previously designated in Rule 318A a Rule 318A a(2) requires a well location to be within a square with sides eight hundred (800) feet in length, the center of which is the center of any governmental quarter section

The Wandell 6-4-7, 8-2-7, and 6-0-7 wells are staked at locations 4', 11', and 18' north of the defined 400' window EnCana has staked the wells with your consent and approval and respectfully requests your consent to an exception location for the three (3) Wandell Wells by waiver of the COGCC Rule 318A a(2)



Rule 318A c (2) states

"When the operator is requesting a surface well location greater than fifty (50) feet from a well (unless safety or mechanical considerations of the well to be twinned or topographical or surface constraints justify a location greater than fifty (50) feet), the operator shall provide a consent to the exception signed by the surface owner on which he well is proposed to be located in order for the Director to approve the well location administratively "

The Wandell 6-0-7, 8-2-7, 6-4-7, and 8-4-7 wells were staked at the following locations west of the existing Wandell 42-7 located in the same drilling window.

WANDELL 6-0-7	110' WEST
WANDELL 8-2-7	100' WEST
WANDELL 6-4-7	90' WEST
WANDELL 8-4-7	80' WEST

As these locations were staked with your consent and approval, EnCana respectfully requests your consent to an exception location for the Wandell 6-0-7, 8-2-7, 6-4-7, and 8-4-7 wells by waiver of the COGCC Rule 318A c (2)
