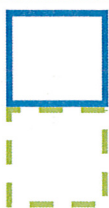

Bottom Hole Located N/2, Sec. 23, T6N, R65W

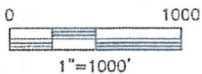
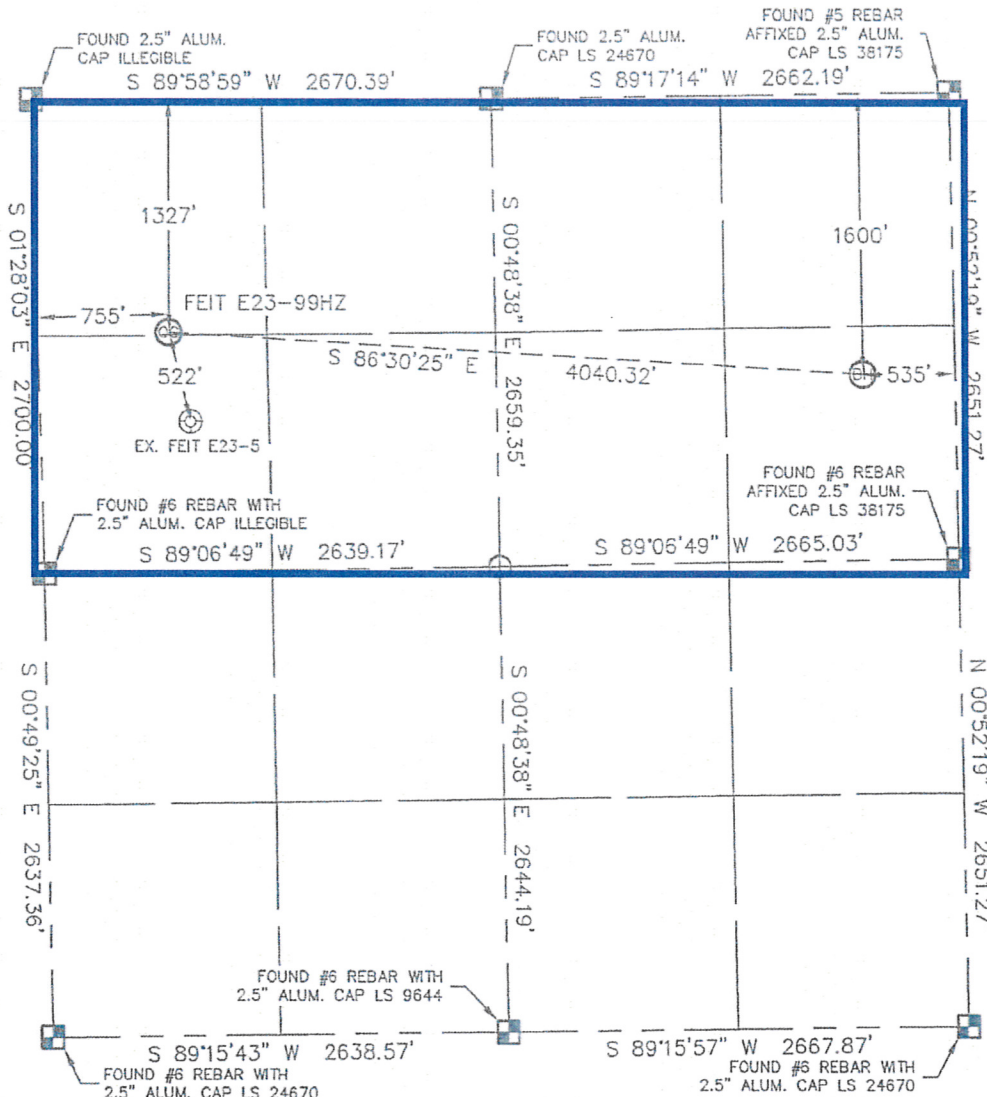

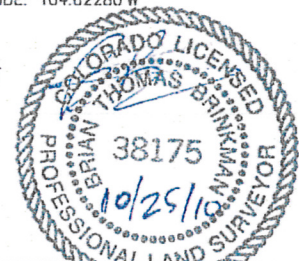
