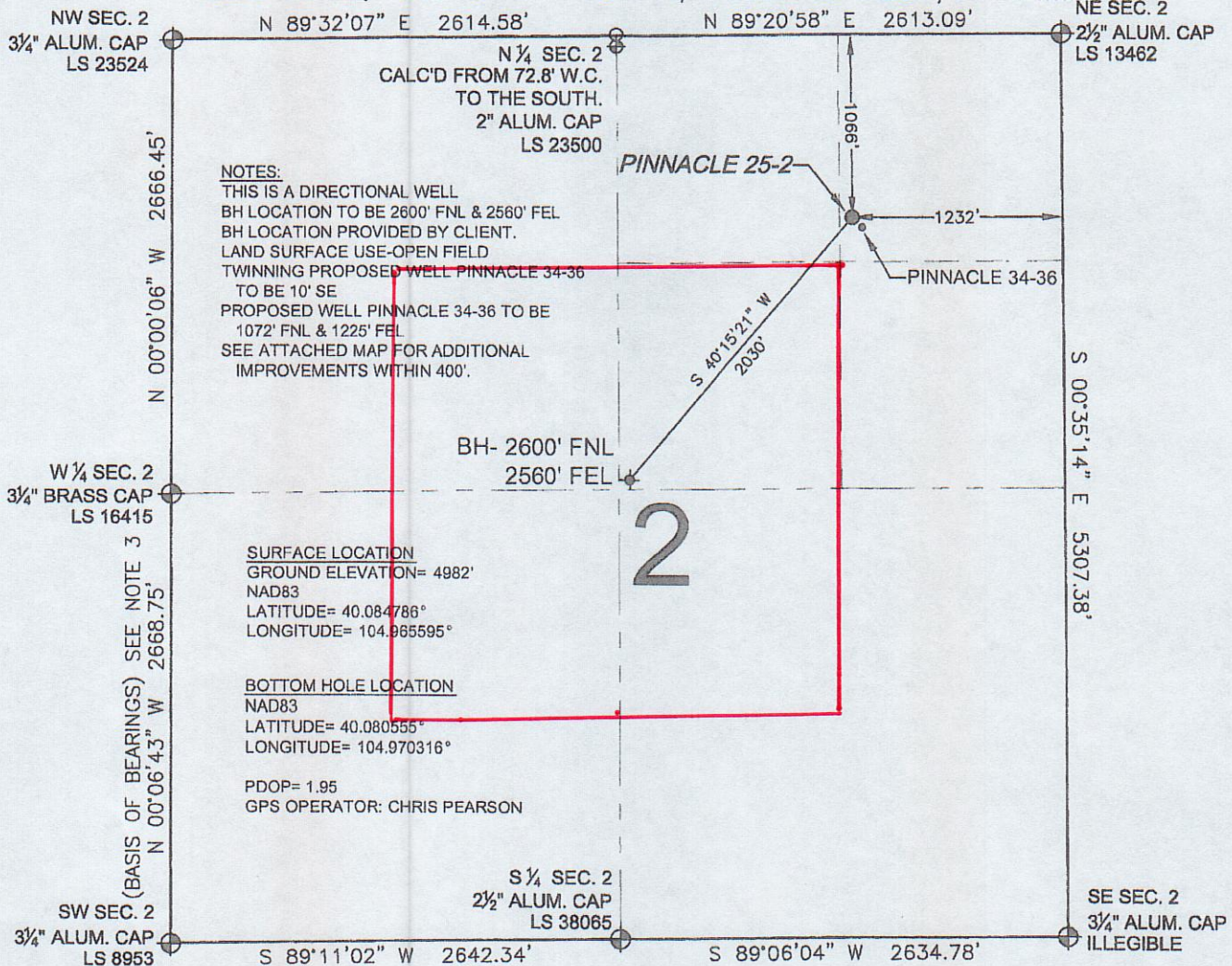

# WELL LOCATION CERTIFICATE: PINNACLE 25-2

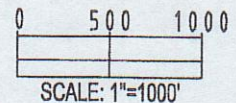

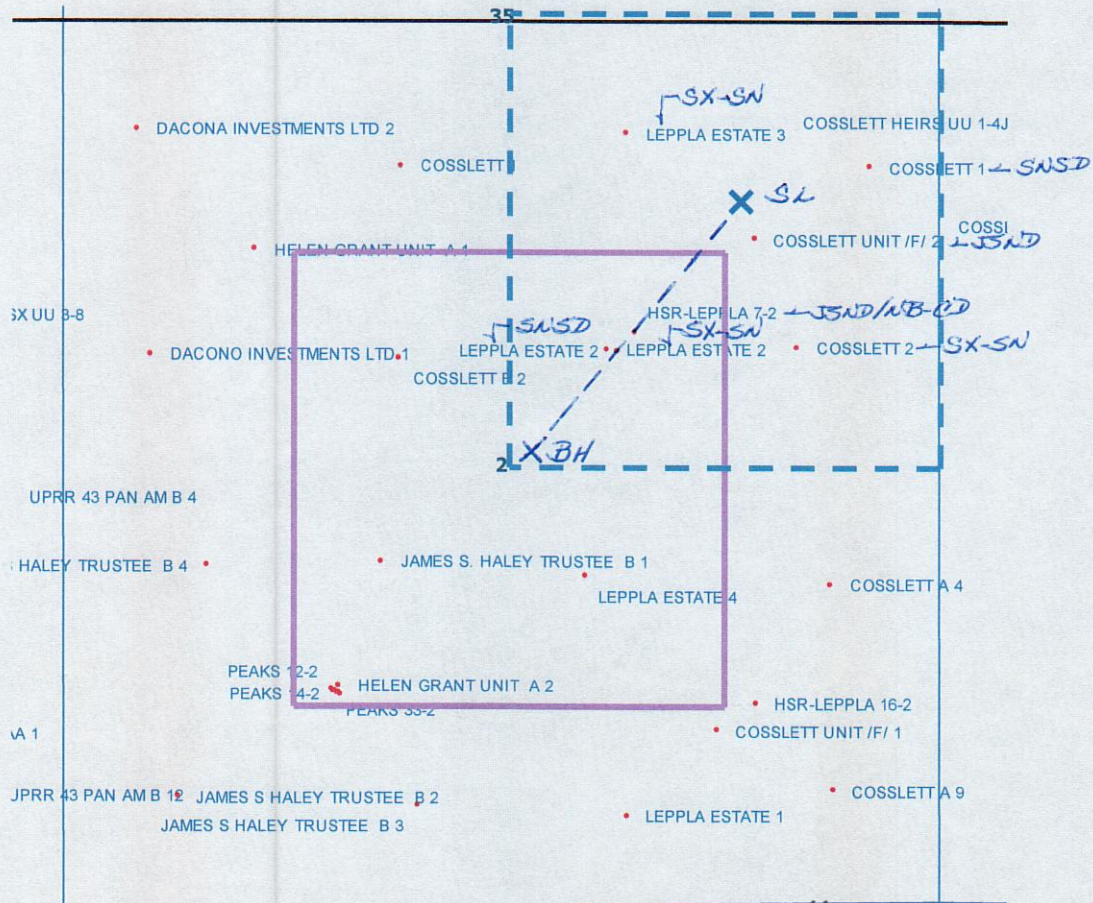
