We will be setting a pumping unit sometime in the future as determined by daily production. The nearest Railroad is greater than 1 mile from location. The reference area is on undisturbed ground immediately adjacent to and South of the facility location as shown in the location photo facing South. Sensitive area due to location in Northern High Plains Designated Groundwater Basin and closest well being having domestic use status. Separator may be set at meter shed if determined necessary. This location was abandoned on Berry Petroleum's behalf, but Augustus Energy purchased Berry Petroleum 04/01/09 and Augustus would like to refile this location using the existing API #. A change of operator has also been submitted (11/11/10) changing the location from Berry to Augustus. All conditions remain the same.

Each location's BMP's will vary according to terrain and phase of construction and will be implemented in accordance to SWMP.</p> <p>Regular location inspections will be performed and any BMP's not effectively working will be documented and resolved in a timely manner.</p> <p>Spill Prevention, Control and Countermeasures will be implemented. Should any spills occur they will be cleaned up immediately and effectively to minimize any integration with storm water runoff. General good housekeeping practices will be performed to keep spills at a minimum.</p>
