As you can see below, a Form 19 and supporting documentation was submitted on 12/7/09 for the subject site located in the NENE Section 33 – T6N – R64W. Approx. 120 cubic yards were removed for offsite disposal. Lab results of confirmation soil samples showed compliance with Table 910-1 Concentration Levels.

A recent check of COGIS indicates that this spill has not been closed by the COGCC. Could you please review at your earliest convenience for PDC's No Further Action request. If there is any additional information that needs to be submitted, please inform accordingly.

New Release Notifications

Sughrue 41-33 - NENE 33 6N 64W... 05-123-14261... Weld - I would like to notify you of a historical release of an unknown quantity at the Sughrue 41-33 facility. The release was estimated at 10-15 bbls of produced water and condensate around a concrete vault area. We discovered the contamination while replacing the concrete vault with a new fiberglass pit. 120 cu yds of contaminated soil was taken to North Weld Waste Management Facility. 5 confirmation soil samples were taken and results confirmed all samples were below COGCC standards for GRO-DRO and BTEX. No surface or ground water was impacted. I have attached a form 19 and supporting documentation on the project for your review. PDC is requesting no further action status be granted for this site.

Reider #1 - NESE 5 4N 67W... 05-123-10970... Weld - I would like to notify you of a historical release at the Reider #1 facility. The release is of an unknown quantity of produced water and condensate around a concrete vault area. We discovered the contamination while performing production pit closure operations after a P&A procedure on the well. We currently have 180 cu yds of contaminated soil removed to North Weld Waste Management Facility. No surface or ground water has been impacted. We are still working to clean up the remaining soils in the vault area. I have attached a topographic map of the site for your review. If you approve, and providing we do not encounter ground water, I will wait until we have lab results back from the confirmation soil sampling before submitting the required Form 19.

Project Update- Green 11-24 - NWNW 24 7N 65W..... 05-123-22851
Confirmation soil samples were taken last week. Result will be available from Origins Lab on Wednesday. Assuming the site is clean I will forward all final documentation to you at that time.
