Mike,

I'm looking at the information you sent, and I think I have figured out the Ft. St. Vrain projects.

At the #4 well (API 123-10163), there have been a total of 3 incidents reported. Two of these are combined under one Remediation #, and the third has a separate Remediation #. Remediation is on-going on both of the Remediation projects.

At the #13X tank battery (API #123-10456), there is one incident with one Remediation # that is on-going.
1396463 1396784 3865

It appears that I can close the open Form 19 #1982383 with reference to the on-going Remediation #4315 (which is where my original query started).

Also, Document #2606755, filed under Remediation #4315, relates to the injection that happened at 13X and should be moved to Remediation #3865.
