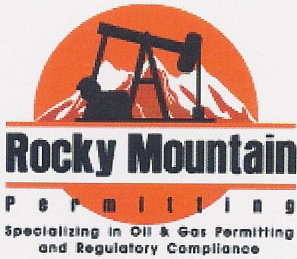

Dear Mr. Shapley:

In accordance with Rule 305.e.(1).B of the Rules and Regulations of the Colorado Oil and Gas Conservation Commission ("COGCC"), this letter serves as a 30-day notice by Rex Energy Rockies, LLC ("Rex") of its intention to commence operations for the drilling of a well on the above-referenced location.

Rex's operations are estimated to begin within the next 90 days from the date of this letter or as soon as operationally practical after receipt of an approved Application for Permit to Drill (APD). COGCC regulations provide that the surface owner may waive the 30-day notice requirement.

In an effort to expedite the process, Rex Energy Rockies, LLC, is requesting the surface owner, Dewain Shapley, to waive the 30-day notice to surface owner in compliance with *Rule 305* of the Colorado Oil and Gas Commission. Enclosed is a waiver form. Please read and fill out the form stating your decision on the thirty (30) day notice as required by Rule 305. Return the fully executed form in the self-addressed, stamped envelope provided.

Enclosed is a "Well Location Plat", "Proposed Pad Layout" and "Access Road Map".

As the surface owner, it is your responsibility to notify any affected tenant farmer, lessee or other party that may own or have an interest in any crops or surface improvements that could be affected by these proposed operations.


