Railroad is 2.46 +/- miles away from site. There are no visible improvements within 400 feet of site. There is a plugged and abandoned well location (Fulscher 1) 188 feet south of site. Land is currently in cattle pasture. Nearest water well 1,051 +/- feet from site (RECEIPT: 9054620; PERMIT: 19589-F; USE: Irrigation). There is an ephemeral playa located 742 +/- feet northeast of location. The location is in a sensitive area due to being within the Northern High Plains Designated Basin. No COAs are needed for this location. A Pump Jack may be necessary to place on facility in the future to help with gas production. It will require either one gas or one electric motor to run the pumping jack unit which will be determined at the time of installation.
