This well is covered by the Master Surface Use Plan dated 01/01/09 for the original Carl Allen #30 location. Due to archeological discoveries Carl Allen #30 was drilled from the Carl Allen #31 pad, leaving this location partial constructed. To utilize a previously disturbed area the surface location of two, Carl Allen #38 and #39, directional wells were plotted at this location. A tank battery will be installed with secondary containment with 110% capacity of the largest tank.
