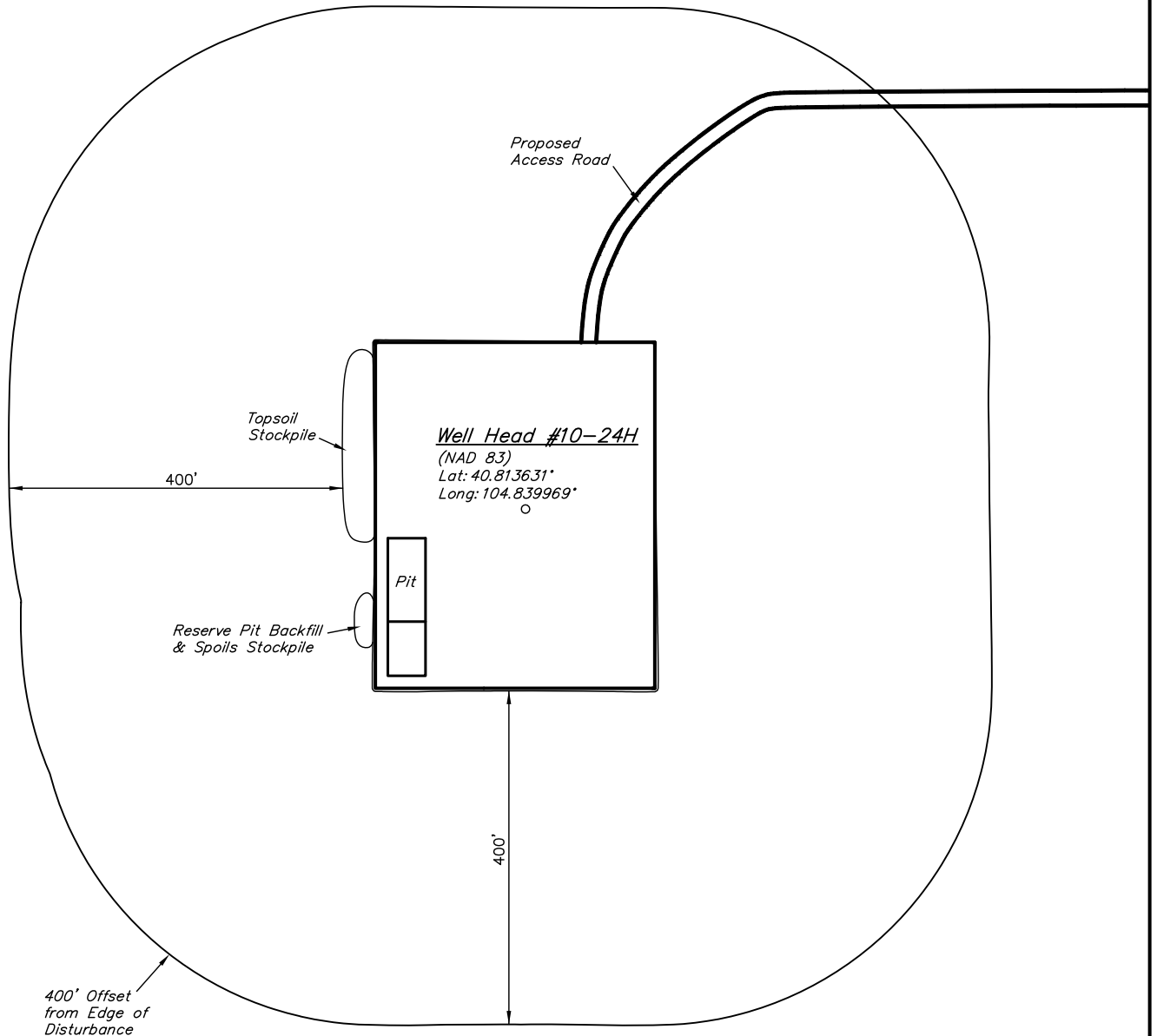

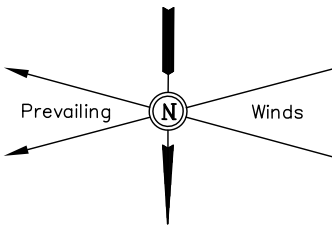
CONSTRUCTION LAYOUT FOR

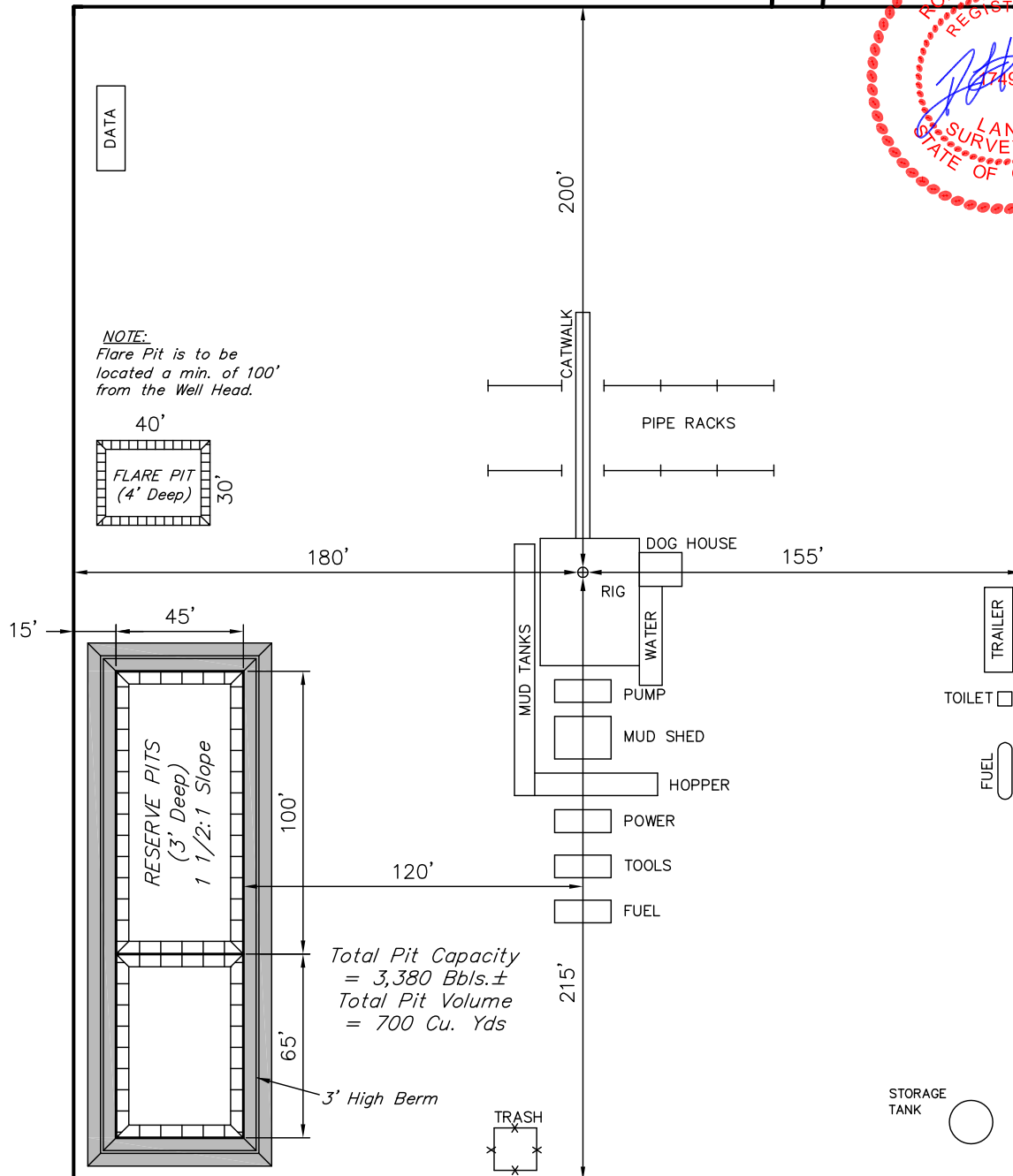

Access Road



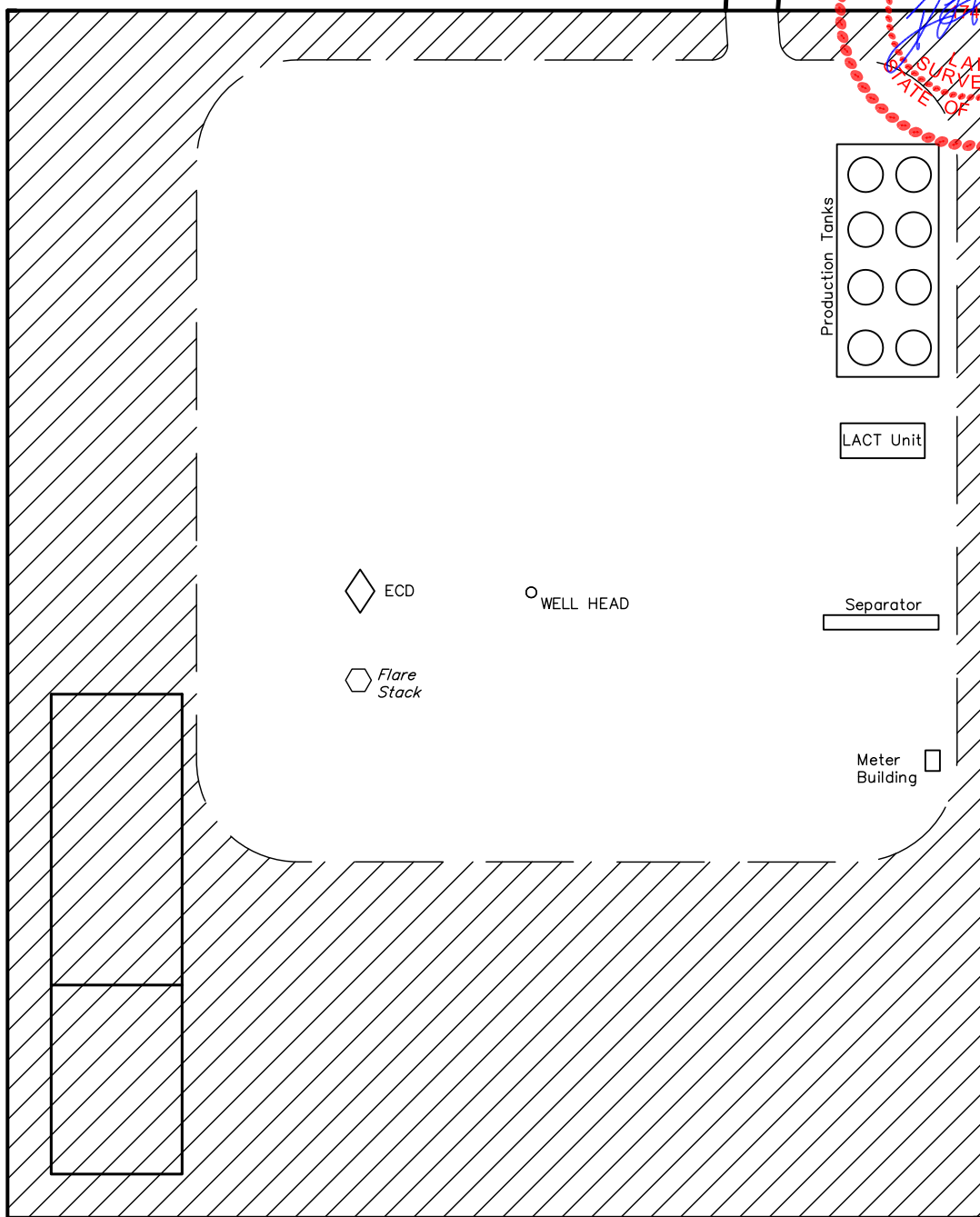
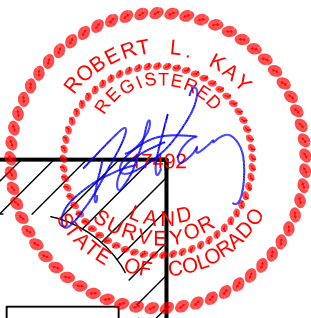

UN-RECLAIMED = ± 1.638 ACRES



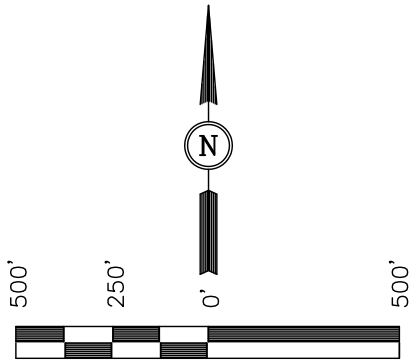

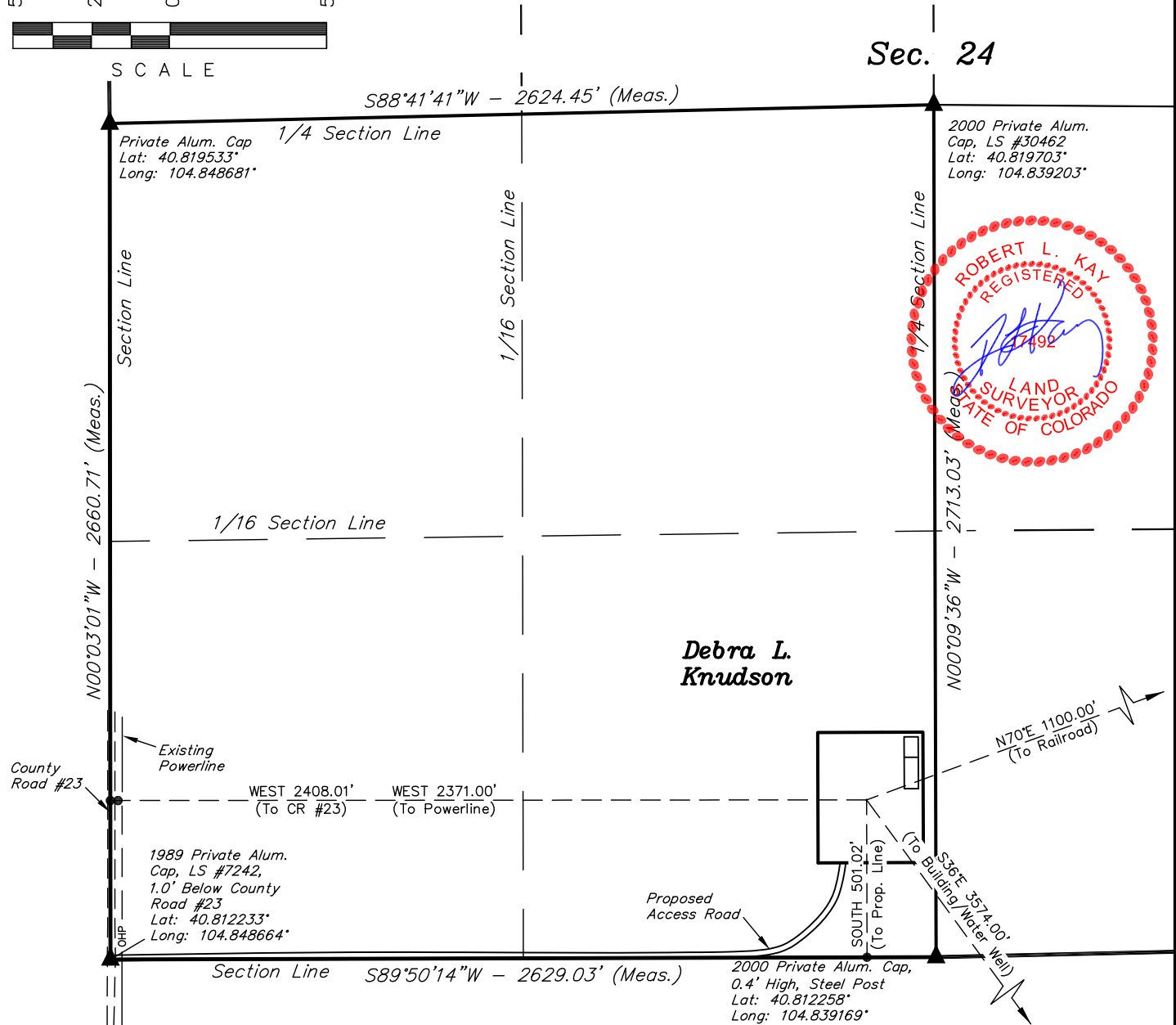
