

5. **DESCRIBE PROPOSED OR COMPLETED OPERATIONS**

The Shell 797-03-37 well was originally permitted to an MD of 6995'. Oxy proposes to increase the MD to 7200', an increase of 205'.

There is no change in the objective formations as a result of the increase in MD.
