Flare Stack to be removed after gas line installation. One of the two heater treaters will be removed when production volumes fall below the capacity of a single heater treater. Water Well information obtained from water well permit #143798 to the Northeast of proposed location. The reference area is on undisturbed ground to the Northwest of the proposed location. The closed loop system utilized to drill the referenced well is a semi-closed loop system. Drilling mud and cuttings will be remediated prior to burial onsite.
