The COGCC is reviewing the Form 2A oil and gas location assessment for the JACKSON DRAW 18-27H well location in the NWNW Sec27 T9N R61W, Weld County, and requests the following changes to the Form 2A that EOG has submitted:

1) Water Resources: The surveyor map shows the nearest water well to be located 1909 feet south-southwest of the proposed location, which appears to coincide with a windmill shown on USGS maps. Please approve me changing the distance to nearest water well from 4891 feet to 1909 feet.
