

Proposed 160 acre Spacing Unit (Solid line).




Bottom Hole Located NW/4SE/4, Sec. 10-T3N-R65W (Dashed line).

**This 1/4 Section has less than 8 bottom hole wells producing from the Codell, Niobrara & J Sand Formations.**




