Dear Mr. MacDonald:

Reference is made to a similar Notice Letter to this one I hand delivered to you on November 11, 2010. PDC has changed its well numbering system, so I am sending you another Notice Letter. I am also enclosing a consultation postcard which I failed to give you on November 11th. Please complete the postcard and return it. In accordance with the requirement of Rule 305.e.(1).B. of the Colorado Oil and Gas Conservation Commission (COGCC), this letter serves as a 30-day notice by Petroleum Development Corporation (PDC) of its intention to conduct drilling operations on the captioned well. I will be contacting you shortly to schedule a consultation to discuss the location of the wellsite, access roads, production facilities and other related matters; however the well location may be staked prior to a consultation. Pursuant to Rule 306, you may also use the enclosed postage prepaid postcard to request a consultation or to designate a representative for surface consultation.

Enclosed is an aerial photo that depicts the area, within which the well may be located, and the location of the existing wells, access roads, and production facilities. It is anticipated that the new production facilities associated with this well will be located near and adjacent to the proposed well, and that access will be from the west in order to minimize interference with your coal mine reclamation operations. Additionally, enclosed please find a copy of the COGCC's brochure describing surface owner rights and responsibilities, and a copy of the COGCC's on-site inspection policy.

As surface owner you have the responsibility for notifying any affected tenant farmer, lessee or other party that may own or have an interest in any crops or surface improvements that could be affected by these proposed operations. At this time, PDC anticipates commencing drilling of this well in mid April, 2011.
