Kris,

I have reviewed the Notice of Completion (NOC) report for the Clough RMV 8-16 completion pit (Remediation #4870) on behalf of Chris Canfield.

Please find attached the No Further Action Letter for this Pit Closure Project.

I have closed the project with a Form 27A.

Note: The original Form 27 submitted in January 2010 was entered twice in COGCC database with Remediation #s 4870 and few months later with #5062. I personally removed the duplicate and left the one identified as REM #4870. I apologize for the confusion. The NOC report and the Form 04 requesting consideration of background levels have been uploaded to COGCC database and linked to REM # 4870.

Note 2: The NOC report indicates that post-treatment TPH concentration (south section of the bottom of the pit) was 580 mg/kg, a bit above Table 910-1 limit of 500 mg/kg, and that it was treated in-situ to lower the TPH concentration. Although TPH concentrations at the bottom of the pit were most likely below Table 910-1 value after completing the in-situ bio-remediation, I would like to point out that confirmation samples need to be submitted to demonstrate that impacted areas have been properly treated to lower concentrations below Table 910-1.
