


WELL LOCATION CERTIFICATE

Lat40°, LLC has determined the surface location of the WELLS RANCH USX BB15-67HN to be 1850' from the NORTH line and 217' from the WEST line and the bottom hole to be 1320' from the NORTH line and 535' from the EAST line as measured at right angles from the section lines of Section 15, Township 5 North, Range 63 West of the Sixth Principal Meridian, County of Weld, State of Colorado.




