Distance to nearest railroad is greater than one mile. Nearest water well at 801' is an irrigation well; Receipt #C620426, Permit #426-WCB- with a depth of 47' and a static water level of 7'. A consultation with the property owner confirmed that the well is mapped incorrectly; it is located approx 801' SE of the proposed well. Proposed HBR PC G11-21D will be drilled 47' from existing Hanscome 6. The production facility will be built 833' SW of the HBR PC G11-21D, at the existing facility for the Hanscome 5 & 6.
