Re: Re-entering the Genesis #1 well to complete in the Niobrara Formation

To whom this may concern:

Our records, based on the tax assessor records of Weld County, indicate that you are the surface owner of the lands located in the SW/4NW/4 Section 16, Township 4 North, Range 66 West, 6th PM, Weld County, Colorado. The **Genesis #1** location has been surveyed in and staked at 1957'FNL, and 612' FWL of Section 16. In accordance with the Colorado Oil and Gas Conservation Commission, Rule 305 e.(1)A: *Advance Notice of Intent* shall be mailed or hand delivered to the surface owner not less than thirty (30) days prior to the date of estimated commencement of operations with heavy equipment. This letter shall serve as proper advance notification to the surface owner. ***We are not moving in heavy equipment at this time, this notification is for permitting the location only.*** The complete application will be available on the website after the application is tendered and the surface owner will have notice at the time the application is tendered to the COGCC.

Kauffman Company, Inc. has the right to enter the lands and will be conducting re-completion operations on the above location(s). The re-entering of the Genesis #1 to complete the Niobrara formation of this well is estimated to commence during the first or second quarter of 2011.




EXHIBIT MAP


