After reviewing the Form 2A and the attachments, COGCC requests the following changes or clarifications for the Form 2A:

- 1) New / Amended Location:** As we previously discussed, this assessment should be for a new location. Please approve me changing the Form 2A from "Amend Location" to "New Location"
- 2) Location Drawing:** Was Noble able to field verify the presence of the water well with permit number 78360? It is not shown on the Location Drawing. If the Location Drawing needs revised with the water well, please do so and I will attach the revised Location Drawing to the Form 2A. Or, please verify that the water well is located beyond the 400 foot buffer from the disturbance. In that case, I will attach the Location Drawing that you have already provided.
- 3) Water Resources:** The location is within 1/8 mile of a domestic well, and therefore is a sensitive area. Please approve me changing the Sensitive Area Designation from No to Yes.
