Flare stacked to be removed after a gas line is installed. One of the two heater treaters will be removed when production volumes fall below the capacity of a single heater treater. Depth to ground water was determined from Water Well Permit # 261616-A (southeast). The closed loop system utilized to drill the referenced well is a semi closed loop system. Drilling mud and cuttings will be remediated prior to burial onsite.
