Flare stack will be removed after a gas line is installed. One of the two heater treaters will be removed when production volumes fall below the capacity of a single heater treater. The closest water well is Water Well Permit #40117 which is located to the northeast of the location in Section 14 T10N R65W. The closed loop system utilized to drill the referenced well is a semi closed loop system. Drilling mud and cuttings will be remediated prior to burial onsite.
