Chesapeake intends on drilling multi wells from this pad. Initially the "surfaced area" of the well pad will not be reclaimed, however all area outside of the surfaced area and areas not used for drilling/completion/production operations within twelve (12) months will be reclaimed as soon as reasonably possible after initial drilling/ completion operations in accordance with Rule 1003.b.. Areas to be used for subsequent drilling and completion operations within twelve (12) months will be stabilized to minimize dust and erosion to the extent practicable. This location is in a sensitive area because of the close proximity to surface water. Operator will ensure 110 percent secondary containment for any volume of fluids contained at the well site during drilling and completion. Operator will implement best management practices to contain any unintentional release of fluids.
