Pursuant to Rule 305 of the Colorado Oil and Gas Conservation Commission (COGCC), this letter is to give you notice that Rosewood Resources, Inc. intends to conduct operations for drilling of a gas well as indicated on the attached plat. If you have a tenant leasing these lands, please notify them of our proposed operations. If you are not the Surface Owner of the above tract of Land, we ask that you please notify this office immediately so that the proper land owner may be notified.

1. Operations with heavy equipment are estimated to commence after the approval of the Application for Permit to Drill (APD) submitted to the Colorado Oil & Gas Conservation Commission and upon crops being harvested if applicable.

9. By signing below (and returning to the undersigned), the surface owner waives the above notification requirements of Rule 305 and acknowledges that upon receipt of this letter Rosewood Resources, Inc. may proceed with drilling at their discretion after providing at least 10 days prior notice.
