Sundance Energy Inc, is planning to drill the above mentioned wells to the Codell/Niobrara formations.

The surface locations of Sundance Energy, Inc's proposed wells have been staked outside of the 318A.a drilling window. The locations are being permitted as exception locations. Sundance Energy, Inc. has obtained written permission contained in a waiver from the surface owner.

Under the Revised Rule 318A.c any new twinning well is to be located within 50' of an existing well. The surface location of Sundance Energy, Inc's proposed wells have been staked approximately 5' from the nearest oil and gas well. Sundance Energy Inc. has obtained permission, contained in the form of a waiver, from the surface owner.



Sundance Energy, Inc. plans to drill the Schell 41-6 and Schell 42-6 wells at the above referenced location, specifically described as Schell 41-6, 180' FNL and 1180' FEL and Schell 42-6, 195' FNL and 1180' FEL. The wells being proposed are outside the Greater Wattenberg field drilling window. COGCC Rule 318A.a requires a well to:

- (1) A square with sides four hundred (400) feet in length, the center of which is the center of any governmental quarter-quarter section ("400' window"); and,
- (2) A square with sides eight hundred (800) feet in length, the center of which is the center of any governmental quarter section ("800' window").
- (3) Absent a showing of good cause, which shall include the existence of a surface use or other agreement with the surface owner authorizing a surface well location outside of a GWA window, all surface well sites shall be located within a GWA window.

By signing this letter you hereby grant your consent for Sundance Energy, Inc to locate Schell 41-6 and Schell 42-6, at Schell 41-6, 180' FNL and 1180' FEL and Schell 42-6, 195' FNL and 1180' FEL.
