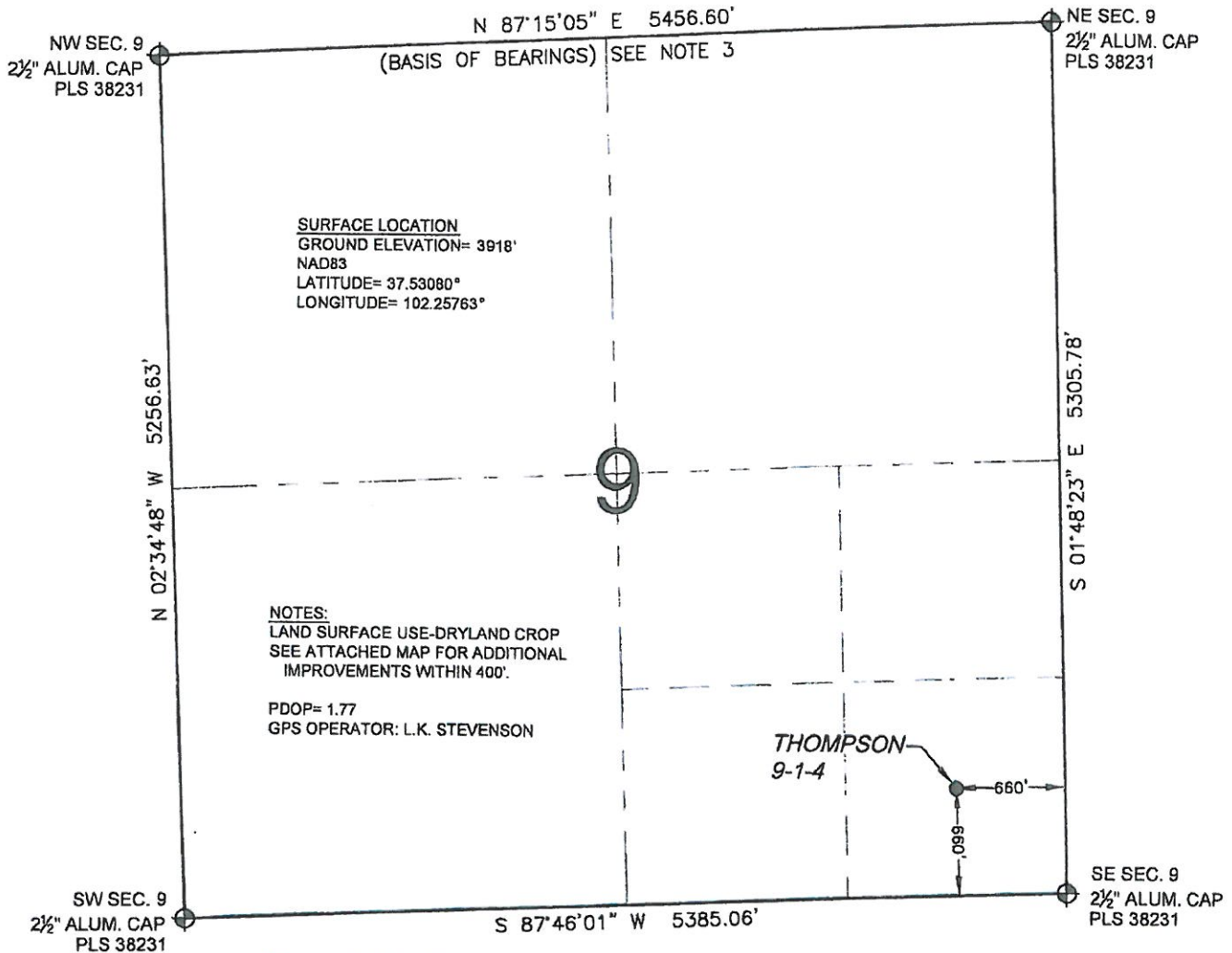


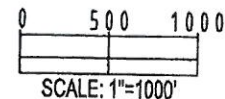
WELL LOCATION CERTIFICATE: THOMPSON 9-1-4
