33. Comments I certify that conditions from the last approved permit are the same except updated SHL and BHL and casing/cementing program has been updated. There have been no other changes to land use, well construction or the lease. This Refile Form 2 does not require a Form 2A because the pad has been constructed, a closed loop system is being used so no pits need to be constructed, the refiled well will not require any expansion / additional surface disturbance of the pad. The location is not in a wildlife restricted surface occupancy area (RSO); consultation with CDOW is not required and the location does not require a variance from any of the rules listed in Rule 306.d.(1).(A).(ii).; consultation with CDPHE is not required. Please note, however, that a Form 2A has been filed per Rule 303d.(1) in conjunction with a new well that is being added to this pad (the McPherson A10). #31 Mud Disposal: Antero will bury onsite if disposal meets Table 910 and if there is a provision in SUA which allows for such operation.
