At this time, DOE does not request any additional information but would encourage COGCC to place general language in the permit such that the company would accommodate DOE sampling requests in the future. DOE agrees with the COGCC assessment that the surface location is in the NESW Section 12 7S 95W and is over three-miles from the Rulison well and outside the notification zone. The bottom-hole-locations are also located in Section 12 and range from 2.76 to 2.95 miles from the Rulison well. DOE agrees with COGCC that these wells fall under the Tier 2 sampling and monitoring requirements of the COGCC Rulison Sample and Analysis Plan and the wells are located in Sector 1 and 12 of the Rulison SAP. DOE will continue to review the proposed locations and subsurface orientations of the propose drilling for documentation when sampling occurs.
