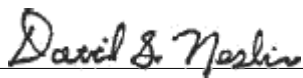

All representations, stipulations and conditions of approval stated in this Form 2A for this location shall constitute representations, stipulations and conditions of approval for any and all subsequent operations on the location unless this Form 2A is modified by Sundry Notice, Form 4 or an Amended Form 2A.

Operator must implement site-specific best management practices in accordance with good engineering practices, including, but not limited to, construction of a berm or diversion dike, site grading, or other comparable measures, sufficient to protect Eureka Creek located 331 feet north of the oil and gas location from a release of drilling, completion, produced fluids, and chemical products.

Location is in a sensitive area because of shallow groundwater; therefore, either a lined drilling pit or closed loop system is required.
