Dear Mr. & Mrs. Kirchenschlager,

Per COGCC rule 318c, we would like to request an exception location waiver for the drilling of the above referenced well. The proposed well falls under WLR 318B which requires the location to be 300 feet from a lease line and 300 feet from a section line. The proposed location will be approximately 55 feet west of the lease line of NW/4 of section 11-T1N-R47W in which you are the surface and mineral owner.

We feel the exception location will place us in the best amplitude signature and gain approximately 25 feet of structural advantage versus the nine (9) feet of structural advantage at the legal location to produce an economic well. If placed in a legal location the well would be uneconomical based on the performance of the two plugged offset non-commercial producers which are in minimal amplitude and low structural positions equivalent to the legal location.

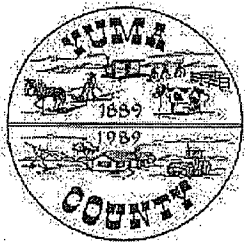

The request submitted by Augustus to close County Road M when drilling well D Blach 42-10 located in Section 10, 1N4 R47W has been reviewed. We understand that the well will be drilled within 150 feet of County Road M and according to COGG regulations the road would need to be closed while drilling at the proposed location.



The Application will allow review of the dates the road will be closed, fee associated for closing the road, and any special circumstances that may need addressed prior to closing the road.


Please use this letter as confirmation that Yuma County will allow closing this section of the road with the above stipulations.

Dear Mr. Dunker:

Per COGCC rule 603, during the time of initial drilling we are required to be one hundred fifty (150) feet or one and one-half (1-1/2) times the height of the derrick, whichever is greater, from a public road and/or major above ground utility line. Our proposed location will be approximately 55 feet west of county road M and approximately 110 feet west of the overhead utility lines.

Due to our location falling within the one hundred fifty (150) foot setback we are requesting your approval and assistance to disconnect the electrical service during the drilling time frame. It is our understanding that the location can be easily disconnected, therefore, requiring minimal Y-W Electric man power and materials.
